

PHONE SCAMS

People lose a lot of money to phone scams – sometimes their life savings. Scammers have figured out countless ways to cheat you out of your money over the phone. In some scams, they act friendly and helpful. In others, they threaten or try to scare you. They'll do what it takes to get your money or your personal information to commit identity theft. Don't give it to them. Here's what you need to know.

Phone scams come in many forms, but they tend to make similar promises and threats, or ask you to pay certain ways. Here's what to know. go directly to the charity's mission and always check out a charity

There is no prize. The caller might say you were "selected" for an offer or that you've won a lottery. But if you have to pay to get the prize, it's not a prize.


You won't be arrested. Scammers might pretend to be law enforcement or a federal agency. They might say you'll be arrested, fined, or deported if you don't pay taxes or some other debt right away. The goal is to scare you into paying. But real law enforcement and federal agencies won't call and threaten you.

You don't need to decide now. Most honest businesses will give you time to think their offer over and get written information about it before you commit. Take your time. Don't get pressured into making a decision on the spot.

Only scammers demand you pay certain ways. Scammers will often insist you pay in a way that makes it hard to get your money back - by wire transfer, gift card, cryptocurrency, or a payment app. Anyone who insists that you can only pay that way is a scammer.

Government agencies won't call to confirm your sensitive information. No government agency is going to call you out of the blue and ask for sensitive information like your Social Security number. They're lying if they say they're with a government agency you know, like the Social Security Administration or IRS.

You shouldn't be getting all those calls. If a company is selling something, it needs your written permission to call you with a robocall. And if you're on the National Do Not Call Registry, you shouldn't get live sales calls from companies you haven't done business with before. Those calls are illegal. If someone is already breaking the law calling you, what they're calling about is probably a scam.



Any scam can happen over the phone. But here are some common angles phone scammers like to use:

Impersonator scams. A scammer pretends to be someone you trust - a government agency like the FBI, the sheriff's office, or a court official, a family member, a love interest, or a business you recognize that claims there's a problem with your computer. The scammer can even have a fake name or number show up on your caller ill to convince you.

Debt relief and credit repair scams. Scammers will offer to lower your credit card interest rates, fix your credit, or get your student loans forgiven if you pay their company a fee first. Don't believe them. You could end up losing your money and ruining your credit.

Business and investment scams. Callers might promise to help you start your own business and give you business coaching, or guarantee big profits from an investment - maybe investing in cryptocurrency. Don't believe it. Check out investment opportunities with your state securities regulator.

Charity scams. Scammers like to pose as real charities and might ask for donations for disaster relief efforts, support for local law enforcement or veterans, or money for kids and families dealing with cancer. Always ask how much of each dollar you donate will before you give. Never feel pressured to give immediately over the phone.

Extended car warranties. Scammers find out what kind of car you drive and when you bought it (or pretend to know) so they can urge you to buy overpriced - or worthless - service contracts or so-called extended warranties. Never buy a contract or warranty on the spot, and always research the company and contract or warranty before you pay anything so you know if it makes sense for you.

"Free" trials. A caller might promise a free trial but then sign you up for products - sometimes lots of products - that you're billed for every month until you cancel. Never sign up without knowing what happens after the "free trial" ends, and always read your billing statements to look for unexpected charges.

Loan scams. Loan scams include advance fee loan scams, where scammers guarantee you loans or credit cards for an upfront fee. Don't buy it. Honest lenders don't make guarantees like that.

Prize and lottery scams. In a typical prize scam, the caller will say you've won a prize, but then say you need to pay taxes, registration fees, or shipping charges to get it. Hang up. After you pay, you find out there is no prize.

Travel scams and timeshare scams. Scammers promise free or low-cost vacations, but once you respond, you find out you have to pay some fees and taxes first. Or once you pay, you find out there is no vacation. In timeshare resale scams, scammers lie and tell you they'll sell your timeshare - and may even have a buyer lined up - if you pay them first.


Silver Ridge Park Westerly Homeowners Association UPDATED 2025 Pool Rules and Regulations

- All homeowners in good standing as defined by the Bylaws and NJ Administrative Code must be current with dues, assessment or liens. Guests must acquire a pool badge from the pool monitor upon entering the pool.
- All homeowners must show their blue homeowners badge upon entering the pool area to the monitor on duty. Every resident living in a unit that was listed at certification received a badge. If a badge is misplaced or lost, homeowners are required to purchase a new one before the opening of the pool season. The cost is \$18.00 per badge, per homeowner.
- Every home may bring 1 guest free of charge to the pool, however, up to 5 additional guests may accompany a homeowner at a charge of \$5.00 per guest per day or \$15.00 per guest for a season pass. *One free guest per household.*
- Guests will be required to sign in. Additional passes are only to be sold to Silver Ridge Park Westerly homeowners in good standing, not residents of neighboring communities.
- There is **absolutely no** saving of tables, chairs, or lounge chairs.
- Guests under 16 years of age are permitted to use the pool from 10:00 am till 1:00 pm. All under the age of 16 must leave the pool area by 1:15 pm. All under the age of 16 **must** be accompanied by an adult responsible for their safety and conduct. There will be **no** charge for children 16 years of age under to attend the pool.
- Children under 3 years of age are **not** permitted in the pool area. Children must be toilet trained to use the pool.
- Adult, child, and swim diapers are **not** permitted in the pool at any time.
- Individuals with signs or symptoms of infectious or contagious disease, cold, nasal discharge, cuts, bandages, skin eruptions, or other infections are prohibited from using the pool.
- It is suggested that hair longer than shoulder length be tied as a ponytail. Water shoes are permitted, however, they are not to be worn to the pool, but changed upon entering the water. Streetwear is **not** permitted in the pool. Shirts designated for swimming are permitted.
- Food is permitted poolside. It is required that all residents clean up after themselves. No alcohol or glass containers of any kind are permitted poolside.
- Running or rough and rowdy playing is not permitted in the pool area. Rafts, footballs, and toy surfboards are **prohibited**. Arm floats, noodles, noodle chairs and belts are allowed. Beach balls can be used for tossing around and/or volleyball by adults as long as the pool is not crowded and residents in the pool are asked first.
- Diving and jumping of any kind is **not** permitted.
- No animals are permitted on the pool property.
- Wet bathing suits are **NOT** permitted in the clubhouse/kitchen. Please use footwear when entering restrooms, clubhouse, and kitchen areas.
- Smoking and vaping are permitted only outside of the pool area in designated smoking areas.
- The pool committee members, designated pool monitors and the board of trustees are the final authority on

questions and interpretation of the listed regulations. This includes questions concerning decorum conduct and admissions.

- The Board of Trustees reserves the right to close the pool area for club events.
- Failure to abide by the above rules may result in the forfeiture of your pool access for a period of time to be determined by the Board of Trustees.
- Pool hours are from 10:00 AM- 8:00 PM. The pool is open for any homeowner who wishes to do morning swimming laps only at 9:00 AM, however, a second person must be present at the pool. There is NO swimming unattended.
- There is no swimming after 8:00 PM unless of a function that has been approved by the Board of Trustees.
- The Board of Trustees revised these rules and regulations on March 18, 2025. 2nd Revision 3/24/2025 3rd Revision 3/26/2025, 4th Revision 5/13/2025
- The above rules and regulations are effective as of 1st day of pool opening in the 2025 season. Approved by SRPWesterly Board of Trustees

JUNE Dirt - Lawn Sprinkers 101 from the Silver Ridge Park - Westerly Garden Committee 2025

For those of you who currently use an automatic sprinkler system to water your grass, here are some tips to save water, save money on your electric bill and save wear-and-tear on your system.

1 - Operate your sprinkler system only during pre-dawn hours for most efficient watering. If it takes 2 hours to go through all of your zones, then your sprinkler should turn on at 5am and go off at 7am or you will lose moisture due to evaporation once the sun comes up. Early-morning watering (instead of at night) also gives the grass blades a chance to dry out during the daylight hours which will help stop any fungal issues on your lawn. You also do not need to water your lawn every day. Typically 1" of water per week is sufficient for most grass types and it encourages the grass to grow deeper roots to better sustain itself.

2 - Your sprinkler system should have a 'smart rain-sensor' built into it. This device will tell your system when it is raining outside and that there is no need to operate at that time. Smart sensors are worth the investment as they can significantly reduce your water usage, save money on your electric bill that runs your pump and minimize wear-and-tear on your irrigation system. If enough rain has fallen, then the sensors let the timer know to skip the next cycle and not run. Most of us do not pay for our sprinkler water, but it is very wasteful on our Pine Barrens groundwater if your sprinkler system is running during a rainstorm. Rain sensors will pay for themselves over time.

3 - Do not irrigate your driveway or the sidewalk. If after your sprinklers have turned off and you see water running down the curb into the street, something is wrong. You either have improperly positioned sprinkler heads watering your hard-surfaces, or you are running the system too long or there is a busted sprinkler head. Find out the problem and get it fixed.

Whether it falls out of the sky or comes out of our pipes, water keeps our lawns and plants green and growing. The reason we can live on this planet is because of water! Is it just a coincidence that water covers about 70% of the Earth's surface and our human bodies are made up of about 70% water?

The time cost to you, the homeowner, would be the requirements to water the tree and maintain the enclosure for 12-months after the installation. Once installed, your tree becomes the property of the SRP Westerly HOA.

It is recommended you speak with any neighbors about the plan installation of your tree. 

In keeping with Berkeley Township shed ordinance, homeowners are permitted, effective immediately, to install one (1) shed on their property, up to and including 64 square feet. (8' x 8' x 8')

Modification of existing shed policy 11th in the architectural Rules and Regulations was voted for, approved and has changed to:


- 1. Sheds may not be placed anywhere other than the rear of the home.
- 2. All sheds must remain within the sidelines of the home.
- 3. Sheds may NOT be installed on common ground property.
- 4. Said shed shall be of any structure material the homeowner desires.
- 5. Sheds that are required to be fastened must be on a firm ground structure. DO NOT place any shed on a cement slab. Cement slabs add square feet to your taxable living space and will be taxed by Berkeley Township.

6. In accordance with Berkeley Township ordinance, sheds must be placed at least three feet from the back of the property line.

- 7. Although Berkeley Township requires only a 3 foot side setback, SRP Westerly requires all shed placement to remain within the sidelines of the home.
- 8. In accordance with Berkeley Township ordinance, electrical wiring of sheds is not permitted.
- 9. If a homeowner chooses to install a shed against their home, it may
- not block any windows or doors.

10. Homeowners MUST submit an architectural approval request form along with a drawing showing the location of the proposed shed to the SR Westerly Architectural Committee. (Architectural forms are available in your monthly copy of the Sign Post).
11. The homeowner must submit a zoning permit application, required fees and forms to the Berkeley Township Town Hall /Zoning Office.

(Zoning Permit Application forms can be obtained from the Berkeley Township website or the Zoning Office.)


